- 2) Instructions for proper use come with each product. In these instructions, Wildlife Control Supplies recommends the use of <u>ear</u> and <u>eye</u> protection with all pyrotechnics.
- 3) Wildlife Control Supplies shall not be held responsible for any injury resulting from the use or handling of these devices whether or not used in accordance with directions.
- 4) The buyer agrees to secure local and state use permits as required.
- 5) The buyer of explosive products must be 21 years of age or older.
- 6) The buyer hereby accepts said material subject to all terms hereof.
- 7) Wildlife Control Supplies' sales records for pyrotechnics and related shipping documents are available to and are subject to examination and review by the Bureau of Alcohol, Tobacco and Firearms Department of the Treasury and United States Department of Transportation.
- 8) Signature by a person over 18 years of age will be required at time of delivery.

I hereby certify that I have a bona fide agricultural or bird control use for these pest control devices and certify that they will be used <u>ONLY</u> for bird and animal control purposes. I further understand that any other use of these items is <u>STRICTLY PROHIBITED BY LAW</u>.
